Colonel Connor: I will bring the attention of one incident on, or a series of incidents that happened with this company, prior to them getting a license. This occurred on August 7<sup>th</sup> in numerous locations within the city. We received upwards of six complaints from separate complainants indicating that the door to door salesmen were aggressively soliciting. We had one individual claim that he bought the product just to get the folks away from his home. After they continued to be persistent we had contact with their personnel; some of their personnel refused to provide identification. The one person we did speak with indicated that his boss told him that they had an agreement with the city, that they could be here. So, some research indicated that these folks were all from out of state; Utah, Maine, Nevada, Nevada, California. The ones that did provide identification, which some did, some didn't. We also in our research realized that the people that actually; this is a company that sprays for bugs, and they do it on site. So, when Joe goes to the door and says I want you to buy this product; they sign the contract and he has a truck come down and they immediately spray. None of the people that were spraying were licensed through DEM, which they are required to do so. I'm not going to offer a recommendation of approval for this company based on those facts, but I'll allow the Board to make that determination.

Chairman Benson: I don't think that I want to approve anything like that.

Vice Chairman Gilbert: I don't know what our latitude is peddlers licenses and where we can go. Colonel Connor: We didn't cite them, but after we ordered them to disperse, probably within the next two hours they continued to pop up in other locations throughout the city. We asked them to call their manager. They didn't know who their manager was. We asked them to provide id, I don't need to provide id, I didn't do anything wrong. So, they were completely uncooperative.

Chairman Benson: So we don't know who even the parent company is.

Colonel Connor: It is a legit company, although I understand they just got their Better Business Bureau license revoked. They're, if you google the company this comes up. It's not quite a scam, but I would liken it to companies that come around offering seal coating, and they basically paint your driveway black and charge you \$1,000. I have more of a problem with the people working for them, and not providing identification. Claiming they had licenses, not providing licenses. Not getting in contact with their bosses, and then once we gave an order to disperse, they popped up all over the city for the next two hours.

**ACTION:** Chairman Benson made a motion to deny. Vice Chairman Gilbert seconded the motion. Chairman Benson, Vice Chairman Gilbert, and Clerk Paolucci voted in favor of the motion. Motion approved.
