 - 5) Duration: 5 years to present



We would like this information delivered in an electronic database format, preferably Microsoft Excel or Access. In the alternative, in a paper format. Please provide any fees required to produce the file so we may remit payment.

I recognize that you may charge reasonable costs for copies, as well as for personnel time needed to comply with this request. If you expect costs to exceed \$10.00, please provide a detailed fee estimate.

The Public Records Law requires you to provide me with a written response within 7 business days. If you cannot comply with my request, you are statutorily required to provide an explanation in writing.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
