

MINUTES

At 7:05 p.m., the Board of Public Safety opened its Fire Session for Tuesday, April 26, 2016. Present were Chief James G. McLaughlin, Chairwoman Leslie Walaska Baxter, Vice Chairman James Paolucci, Clerk Thomas McGovern, Assistant Solicitor Diana Pearson, and Recording Secretary Lisa Ferolito.

1. Based on approval of the action taken in the Executive Session, Chief James G. McLaughlin recommended approval of the following promotions effective Sunday, May 1, 2016:

Lieutenant Bryan Barlow to Captain
Firefighter John Pella to Lieutenant
Firefighter William Lloyd to Rescue Lieutenant

ACTION: Chairwoman Baxter made a motion to approve. Vice Chairman Paolucci seconded the motion. Chairwoman Baxter, Vice Chairman Paolucci, and Clerk McGovern voted in favor of the motion. Motion approved.

2. Chief James G. McLaughlin submitted a retirement request on behalf of Deputy Chief Francis Colantonio, effective Sunday, May 8, 2016 at 75 percent. Deputy Chief Francis Colantonio was appointed to the department of May 6, 1985. Deputy Chief Colantonio will be retiring under the terms and conditions of the Collective Bargaining Agreement, by and between the City of Warwick and Local 2748, International Association of Firefighters, effective dates July 1, 2015 to June 30, 2018 and continuing per Article XVIII. He will retire under Pension II.
