General Communications –

- 1. Ward 4 Council President Solomon The last month has been difficult with many losses. Asks for a moment of silence for Mayor Eugene McCaffrey. He will be delivering a Resolution of Condolence to the family on behalf of the entire council.
- 2. Ward 3 Councilman Howe: Has been working on the flooding and potholes on Lake Shore Drive since April. Asked the city for a temporary fix and got nothing. Even reached out to the National Guard. He commends the residents for their patience and ingenuity in filling the pothole with gravel on their own. People are driving on one resident's grass to avoid this. Has an emergency purchase order for concrete to fill the pothole. With all the letters, phone calls and e-mails regarding this, still nothing has been done and he is furious.
- 3. Ward 6 Councilwoman Travis: School committee tabled money for air conditioning which has already been bought and installed at Gorton Jr. High. They purchased new furniture and overbought tiles. They don't care about taxpayer money.
- 4. Ward 2 Councilman Rix: Regarding flooding in Ward 2, particularly Norwood Field. It is a man-made problem. The drainage system under the field is blocked. The city loses recreation revenue and the residents can't enjoy use of the field. Homeowners are having basement flooding. Residents have come together and remained resilient. Have been enjoying food truck nights and will be holding an upcoming free movie night featuring Batman.
- 5. Ward 7 Councilman McAllister: Requests a moment of silence for Susan Rooney, who passed away on June 21, 2017. She was a special education teacher in Warwick and Cranston for 30 years.
- 6. Ward 4 Council President Solomon: Adds that Susan Rooney was also the wife of former recreation director, Michael Rooney; sister to Senior Service's Gloria Fairbanks, and mother to Golden Apple recipient, Vanessa Rooney.
- 7. Ward 8 Councilman Gallucci: Will call for a meeting between the State of Rhode Island, National Grid, DPW, Kent County Water Authority and the police. They need to work together. National Grid only patches on state roads and they are not going to hold. We require curb-to-curb.
- 8. Ward 9 Councilman Merolla: Sympathizes with pothole and drainage issues. \$2.4 million was put in the budget for road resurfacing, but was not all spent as purposed. Tollgate/Impossible Dream food truck night has been very successful. The

- Greenwich/Narragansett Bay Regatta drew hundreds of people to Warwick and East Greenwich with 70 sailboats racing. It was a great event to bring in and offer to the community.
- 9. Ward 1 Councilman Corley: On July 20 at 7:00 p.m. the Warwick Sewer Authority will hold an informational session on the Governor Francis Phase III sewer project at the Pilgrim Senior Center.
