Gene Nadeau – looking for Warwick's total debt. David Olsen told him it would take 2 weeks. Would like to see that number published.

School Dept budget hearings should end tomorrow night. New Budget looks like increase of \$6 Million. Fire codes are \$12 million over next 3 years. This represents 60% of the \$6 million increase. Suggests using current bond issue money.

Station Night Club Fire caused these new costs. Where are our Senators & Reps?

\$1 Million for Pilgrim, 24 schools total. \$1 Million for books. Budget is being level funded. Will end year w/ surplus. Saved money last Sept w/ unions. Negotiating w/ teachers now. Stop asking for more taxes & start to reduce spending. Time is running out. Our children will not be able to support themselves in the future.

Tessoni wants to give school budgets back to Councils.
