Introduction of New Members

New members introduced themselves. The Chair reviewed the issues the Commission was focused on and the work that had been done to date.

Review of Enabling Legislation Proposal for 2015

The Committee started discussions using the version of the enabling legislation changes that had been voted out of the committee and sent to the City Council the previous year. New members had numerous questions and suggestions. It was clarified that authority to assess a connect capable fee was in the existing law subject to consent by the Mayor and Warwick City Council. There was much discussion the various changes under consideration. Members asked for additional data related to the number of unconnected properties and the impact on rates if all

were to connect. It was suggested to cut down the Summary of Changes document (prepared previously to accompany the redlined legislation) to one page. Sue Baker offered to draft something for the next meeting.

The Chairman reviewed his proposed process going forward and when he had to get the Commission-approved version to the City Council. After the City Council meeting, he plans to meet with the Warwick delegation to the General Assembly along with the Mayor.
