General Communications:

1. Ward 9 – Council President Merolla: Need realistic goals and expectations based on what the city can provide to the school department. Emergency funds are not an option. Council cares strongly about education.
2. Ward 5 – Councilman Ladouceur: Mentoring and special education are important programs. The city charter needs to be changed. Council is not to blame.
3. Ward 6 – Councilwoman Travis: Strongly supports the mentor program. There is too much wasted money.
4. Ward 2 – Councilman Rix: The mentor program is very admirable. Points out that no cuts in administration were made.
5. Ward 3 – Councilman Howe: Was impossible to give the school department what they asked for. \$1.75 million could have saved programs. School department continued drastic cuts and the issue was no longer urgent, which doesn't seem to be genuine.
6. Ward 9 – Council President Merolla: Infrastructure money cannot be used for the school department. We have to prioritize.
