# Public Comment

**RULE 41.** After the General Communications and prior to the Consent Calendar at each City Council Public Hearing meeting there shall be a fifteen minute period during which citizens may comment about Warwick city government issues subject to the following stipulations:

- a) <u>The total period of time for public comment shall be 15 minutes.</u> <u>Comments need to be brief in order to allow as many citizens as possible</u> <u>to participate.</u>
- b) The topics for comment shall be issues directly affecting City government.
- c) <u>City Council members will not respond to questions during the public</u> <u>comment period.</u>
- d) <u>The public comment session will terminate at the expiration of 15 minutes.</u> <u>Waiver of this provision requires unanimous consent.</u>
- 1. Philip L. D'Ercole: Warwick resident and representing Friends of Warwick Pond. He agrees on the matters discussed by Councilman Solomon on the Quarterly Engineering Report and he also feels it was a good report. An ordinance should be in place to cover street sweeping schedule, progress for cleaning and monitoring cleaning of out falls and catch basins to gather data for schedule. If these things are not done pollution will get worse. A schedule will ensure pollution gets better.
- 2. Jody King: Lifelong resident of the City of Warwick, the State of RI recognizes him as Veteran but the City does not. He brings his DD214 to pay taxes but because he was not engaged when active he gets no status in the City of Warwick. This is wrong he should be recognized as a Veteran.
- 3. Tanios Bourmia: Ward 1 resident, here to discuss the Warwick Solar Program. He received quotes a year ago for Tier 1 proposal, which should have been wholesale prices per contractor. The program was extended, he got updated proposal but program restart was not extended. The contractor did not honor Tier III program. They do not offer discount. Contractor will not follow through. Supplier for Warwick Solar Program is not giving discounts.

- 4. Leah Bourmia: Ward 1, Gaspee area, playgrounds are awful. The three in the area, Pawtuxet, Salter's Grove and Bishop Park are unsafe. Village playgrounds should be in neighbor hoods. Please listen up Gaspee area is wonderful to raise family but parks need to be safe and free from drug dealers. There have been no responses to calls to Parks & Recreation. She is asking for help from Council to clean and update playgrounds. She will be happy to give her time and partner with the Council on this project.
- 5. Christina Ginoffi: Speaking for people that cannot speak for themselves regarding smoking; to protect the youth and people not in a financial place to find smoke free housing. No safe level of second hand smoke. There has been good legislation regarding smoking but more is needed. There is no legal right to smoke. I am looking for support and resources to accomplish smoke free housing legislation.
