Public Comment

RULE 41. After the General Communications and prior to the Consent Calendar at each City Council Public Hearing meeting there shall be a fifteen minute period during which citizens may comment about Warwick city government issues subject to the following stipulations:

- b) The topics for comment shall be issues directly affecting City government.
- c) City Council members will not respond to questions during the public comment period.
- d) The public comment session will terminate at the expiration of 15 minutes.
Waiver of this provision requires unanimous consent.

2. Eugene Nadeau – Vice Chair School Committee –School Resolution not drafted – Comment on the state education funding for the City of Warwick he begged everybody that was elected to address this concern. Warwick has been short changed from state funds \$32,000,000.00 and 21,000,000 less then Cranston receives. They are asking for \$4,000,000 more he testified at state house. We have cancelled one item after another that is for the benefit of our school children because of lack of money. Under the arrangements it is unheard of, closing and consolidations. They are working hard the five of them, school committee; they are doing the moves with common sense and respect. He wants Council to know that it is difficult work. On a side note he thinks that the stripping of Representative Solomon Jr. from his assignments at state house is a disgrace.
