- 2. Stacia Huyler: Reads statement on behalf of Rob Cote regarding his compliant to secretary of state of fire department not following records retention policy. Information on bid for breathing air compressor purchase in April was inaccurate. Purchase of additional fire engines are not necessary.
- 3. Cindy Fera: Took two years and \$2,000 to set up her Airbnb. Feels others are being allowed to operate without conforming to the same standards as her business did. Feels she is being singled out and her situation is being ignored by the media and the city.
- 4. Judy Cobdon: Regarding gun violence in schools. The world has changed. She is a 911 survivor. Worked at NYSE. Job was under lockdown. Was evacuated for a bomb scare in her office in the UK. Must be aware and vigilant. Even with high security, atrocities happen. Taking steps to make attacks harder is not being afraid it is taking control. Need to realize our freedoms aren't being taken away, we are gaining control of our safety.
