## **Public Comment**

- 1. Philip D'Ercole: Friends of Warwick Pond would like to thank Council President Travis, Councilwoman Vella-Wilkinson, Councilman Solomon, Councilman Colantuono and all members of the Council for their support of \$1400.00 in 2017 Budget for Warwick Pond. PCO-1-16 should pass with the public's amendments. Consent agreement is good but needs public comment.
