The police department is seeking a 56-6 exception to bid for the purchase of one (1) 2022 Ford Interceptor Utility Hybrid AWD vehicle. This vehicle will be purchased from McGovern Municipal HQ under the Greater Boston Police Council (GBPC) BAPERB cooperative bid. The total cost for this vehicle is \$54,819.35.

The itemized list is as follows:

(1) 2022 Ford Interceptor Utility Hybrid AWD \$54,819.35

The reason for the exception to bid request is due to the immediate availability of this vehicle. This vehicle is approximately \$4,000 cheaper than the non-hybrid 2023 model and even more so when compared the anticipated 2024 model year prices. The 2024 Ford Explorers are set for production in October with an inevitable model year price increase. Based on this, it would be a disadvantage for the city to go out to bid as we've found these government bids out of Massachusetts to be a better option for purchasing new police vehicles.

The purchase of this Ford Interceptor Utility Hybrid vehicle will be part of our FY2024 vehicle purchase plan.

The total amount, if approved, would be \$54,819.35 and would be funded by ARPA Capital Outlay – budget code 510 0400. The police department currently does not have a budget line item for police vehicles.

The police department went out to bid to seek a qualified vendor for the repairs of our motorcycle fleet as needed. The department received one (1) qualified bid for Bid2024-176, Police Motorcycle Repairs.

The vendor is:

Russ' Ocean State, Inc., DBA Russ' Ocean State Harley-Davidson, 35 Albany Rd. Warwick, RI 02888

The department is recommending that the bid be awarded to **Russ' Ocean State Harley-Davidson** as they were the sole bidder. Russ' Ocean State Harley-Davidson is also a Warwick-based business. Their bid rates increased slightly over last year's bid. The police department will pick up and deliver the motorcycles to Ocean State Harley-Davidson when applicable, thus negating the \$125 fee per trip.

The Warwick Police Department does have a fully staffed garage with certified mechanics although none of our mechanics are certified in the repair of Harley-Davidson motorcycles. Allowing our mechanics to work on these motorcycles, even for the smallest repair would not be prudent and could result in liability to the agency and the City of Warwick. The police department currently has a fleet of 7 motorcycles, including 2010 through 2022 Harley Davidson Electra Glide model FLHTP motorcycles. These motorcycles are essential to the mission of the traffic unit; they provide funeral escorts, VIP escorts and are utilized to conduct traffic enforcement.

We request permission to expend up to \$10,000.00, which if approved, would be allocated from the department's budget, code 76-358, "Insurance Proceeds" and/or the department's budget code 30-330, "Auto and Vehicle Maintenance". This contract would be for one year; 12/13/23 through 12/12/24.

The current contract expires on 12/12/23.

Subj: UCMR 5 Testing

The Safe Drinking Water Act (SDWA) requires that once every five years EPA issue a list of unregulated contaminants to be monitored by public water systems (PWSs). This is a mandated program.

The fifth Unregulated Contaminant Monitoring Rule (UCMR 5) requires sample collection for 30 chemical contaminants between 2023 and 2025 using analytical methods developed by EPA and consensus organizations. This first round of samples is required to be tested and results submitted to the EPA by December 2023.

Large public water systems (PWSs) are required to use laboratories approved by the EPA to analyze their UCMR 5 samples. As such, this department has chosen the mostly locally located laboratory to our location, Alpha Analytical in Mansfield, MA. From the list published by the EPA with approved laboratories.

Please accept this memo as a request for a Sec. 56-6, Exception to Notice for UCMR 5 testing requirements as mandated for a two year period beginning from date of award to Alpha Analytical in the amount of \$10,000.
