Francis,

We received four bids from a low of \$109,912 to a high of 119,745 for a 12 passenger paratransit van with two wheelchair positions. The buses quoted were a 2023 GM or 2022 Ford Chassis This a comparison of the two lowest, responsible bidders.

The lowest bidders were Creative Bus Sales with a bid of \$109,912 and Matthews Bus with a bid of \$110,872. Creative Bus Sales bid a Chevy G3500 on a 2022 chassis that is in stock and available in 45 days. Matthews Bus bid was for a Chevy 4500 on a 2023 chassis to be built and available in approximately 90 days.

Creative Bus Sales was non-compliant with explanations in 16 specifications. Of those item the following are most critical:

- The quote is for a Chevy G3500 with 9500# GVW with a 2022 chassis
- No rear dobř
- 5/8-plywood sub-flooring in place of % plywood
- No battery box for duel batteries
- Non retractable seatbelts in the coach area
- Non-specific driver seat

The bid from Matthews Bus was non-compliant in one item, with an explanation of an upgraded replacement. Also as stated, Mathews' bid is for a higher GVW (14,200#) rating and a current year chassis:

The difference between the two bids is \$960. Considering this and the specifications that are non-compliant or replaced, we recommend the bid be awarded to Watthews Bus. Considerations for this offer should be a guarantee to hold this quote for a specific delivery date that would not incur additional cost from third party vendors. Since all of our Transwick buses are currently in good working order, time is not of the essence and a 90 day delivery is reasonable.



The police department previously went out to bid for GeTac F110 tablets and the vehicle mounting hardware associated with the GeTac F110 tablets. This equipment is utilized to outfit new police cruisers and to replace any worn or damaged parts in the older police vehicles. The \$50,000 contract was awarded to Island Tech Services of 980 S. 2nd Street, Ronkonkoma, NY 11779.

The police department is requesting to increase our spending authority by an additional \$60,000 for a new total spending authority of \$110,000. In addition to our originally budged needs, we will now need to upfit various new police vehicles previously purchased with ARPA funding.
