The Department of Public Works is requesting to utilize a government pricing contract for the purchase of a new HG6000 horizontal grinder through the Sourcewell Cooperative Purchasing.

This department uses a grinder daily at the compost facility to grind the yard waste and debris that is brought to the facility by residents and picked up curbside by the yard waste vehicles. Currently, this department has been without a working machine at the facility for several months, which is resulting in excessive amounts of debris piles. With the inability to properly maintain the compost area that is regulated by RI DEM, the City is risking the permit granted to continue such operations. Further, the RI Airport Corporation will take issue with the increasing amount of debris as it is in the flight path. And finally, the City has a cap for yard waste at RI Resource Recovery. If exceeded, it will cost \$25.00 per ton to dump the excess yard waste at their facility. This piece of machinery has been viewed by two City mechanics and was reported back that it is a perfect fit for the operations at the compost facility.

Please consider this memo a request for an exception to notice under Sec. 56-6 of the Warwick Code for Vermeer All Roads - Hopkington, under Sourcewell Contract No. 0500119-VRM in the amount of \$787,216.26 for the purchase of a new horizontal grinder.
