NARRATIVE FOR OFFICER JACKSON A ACCIAIOLI

Ref: 23-5548-OF

On 10/20/2023, I, Officer Acciaioli responded to 19 Elks Lane for the report of a camper that had been damaged unintentionally by city workers.

Upon arrival I spoke with the reporting party Kenneth Gallucci (DOB 02/05/1987). Gallucci showed me his Camper RI CA 75178 displayed on a 1988 Chevy Itasca Spirit color white. A small window above the drivers cab on the drivers side of the vehicle had been smashed. Gallucci stated at 0845 hours on 10/19/2023 he took his dog for a walk. His camper was parked on Rose Street directly across from 8 Rose Street, he did not observe any damage to the camper at this time. Between the hours of 1030 and 1245 on that same day Gallucci observed a City of Warwick work truck parked in the area of 8 Rose Street. The city workers were grinding down stumps on the property of 8 Rose Street directly across from where the camper was parked. After the workers had cleaned up Gallucci observed a window on his camper to be broken. The camper was parked with the drivers side of the vehicle facing the direction where the workers were grinding the stumps. This same side of the camper was where the window was damaged. Gallucci confronted the city workers about the broken window to which they denied having any involvement in the window breaking. Gallucci then spoke with the mayors office who advised he should file a claim and a police report. He showed me images taken on his cell phone of the broken glass from the window on the ground mixed with debris from the grinded down stumps and small rocks. it should be noted upon my arrival the camper was not in the same location where the damage had taken place the day prior. However the multiple images Gallucci took on his phone showed me what the damage and surrounding area looked like at the time of the incident. The estimated cost to fix the damaged window is \$250.00 dollars.

Sergeant Zaborski arrived on scene and took pictures of the damage with camera S-5. This report was taken for documentation.






