I am a detailed oriented professional who has demonstrated strong leadership, works very well with others, has strong interpersonal skills and multi-tasks extremely well.

- Supervise department of 146 line officers and manage command staff of the Patrol, Detective, and Community Services Divisions.
- Direct day to day operations of the department, including staffing, budget requirements, and ensuring
 adherence to departments policies and procedures. Collaborate with the Colonel and Deputy Chief to
 establish annual goals and objectives; work with subordinates to implement strategies to achieve them.
- Serve as key liaison for critical incident response for the department. Build and maintain stakeholder relationships within communities; prepare and implement operational plans for major events/incidents, attend various meetings in order to maintain preparedness of the department.

Captain - Officer-in Charge of the Professional Standards Division (2017-2019) (5 line personnel)

- Supervised police officer recruitment drives. Developed strategies and conducted outreach to attract a
 diverse field of candidates. Conducted background investigations of recruits, integrity interviews, and

- Coordinated the receipt and investigation of internal affairs complaints from both citizens and agency
 personnel. This includes investigations alleging excessive force, false arrest, and/or any criminal
 misconduct by members of the Warwick Police Department. Also includes incidents involving the
 discharge of a firearm or any high liability incident by department personnel.
- Served as agency Integrity officer responsible to investigate and report on any complaints involving City personnel directly to the Chief of Police.
- Oversaw and coordinated training of both police officers as well as civilian personnel to ensure the
 agencies needs as well as policies/procedures are being met and to ensure department has reduced
 liability.

Supervised Prosecution Division which manages case preparation and initial prosecution of all criminal
cases, arraignments, felony screening process, Family Court matters, and motor vehicle violations at
Municipal Court and the State Traffic Court. Caseloads of approximately 200-300 per month.

 Worked cooperatively with numerous federal, state and local agencies to ensure timely and efficient adjudication of cases. Served as primary Department contact for these agencies, including the RI Judiciary and RI Attorney General's Office.

 includes working closely in partnerships with various public and private leaders such as the Mayor's

 of the community to address various issues and/or complaints throughout the City.
