On 12/17/19 at approximately 1740 hrs while on patrol I responded to Hull St in regards to this request.

Hull St is a east/west running street off of Speer St which connects to Narragansett Pkwy. The street is about 1/10th of a mile in distance with a prima facie speed limit set for 25 mph. The road is about 20"2' at the western end and about 20"7' at the eastern end. The road is densely populated with 11 houses located on the northern portion and face Hull St. The houses on the southern side face Narragansett Pkwy. Almost all the houses on the southern portion of Hull St. park off of Narragansett Pkwy, there are a couple on the southeast side of the roadway which park off of Hull St. When I was out there today there were no vehicles parked on the roadway.

On 12/19/19 at around 1915 hrs I responded to 91 Hull and spoke with the residents. They expressed concern about getting emergency medical assistance since a house located adjacent to the corner of Hull St and Speer St is a duplex and has many vehicles there at times. They added the people will park on both sides of the roadway making travel for cars tough let alone larger vehicles. Figuring the average vehicle is about 5 feet wide and will park about 1 foot from the curb would leave 14 feet to travel the roadway safely. Add another vehicle parked across the street from that vehicle and the passable area comes to about 9 feet. The average ambulance is 9 feet wide and fire apparatus is about 10.

After speaking with the Ford's and taking into account the size of emergency vehicles I recommend "No Parking This Side" signs be erected on the north side of the roadway (on the telephone poles).

I advised the Fords as well as Councilman Corley of my findings.
