1	Be it ordained by the City of Warwick:
2	Section I. Chapter 8 of the Code of Ordinances of the City of Warwick is hereby amended to
4 5	add the following:
6	Sec. 8-1. – Penaltyies for failure to obtain building, plumbing, electrical and mechanical
7 8	permit <u>s</u> .
9	(a) Any person, firm, corporation or other entity who erects, enlarges or alters a structure, or installs
10 11	or alters any equipment, the installation of which is regulated by an applicable code, without first obtaining a building permit or permits for plumbing, electrical and mechanical from the
12	city shall be subject to punishment as provided in section 1-4. The responsibility for paying the fines or penalties shall rest with the owner of the real estate. These fines or penalties are in
13 14	addition to such other remedies as the city may have.
15	(b) Any contractor, who erects, enlarges or alters a structure, or installs or alters any equipment, the
16 17	<u>installation of which is regulated by an applicable code</u> or performs other work requiring a building, electrical, plumbing or mechanical permit without first obtaining said building permit
18	from the city, shall be subject to punishment as follows:
19 20	(1) For a first offense, a fine <u>or penalty</u> of \$250.00 for each permit <u>plus a processing fee of</u> \$750.00 plus the cost of each building permit that should have been applied for in the first
21	instance. The responsibility for paying the fines, fees or penalties shall rest with the
22	contractor. These fines, fees or penalties are in addition to such other remedies as the city
23	may have;
24	(2) For a second offense within 12 months of the first offense, a fine <u>or penalty</u> of \$500.00 for
2526	each permit <u>plus a processing fee of \$1,500.00</u> plus the cost for each permit that would have been incurred if a <u>building</u> permit were issued in the first instance. The responsibility
27	for paying this the fines, fees or penalties shall rest with the contractor. These fines, fees or
28	penalties are in addition to such other remedies as the city may have.

(3) For a third offense within 12 months of the first offense, a fine or penalty of \$500.00 for

each permit plus a processing fee of \$2,250.00 plus the cost for each permit that would

have been incurred if a permit were issued in the first instance. The responsibility for

1	paying the fines, fees or penalties shall rest with the contractor. These fines, fees or
2	penalties are in addition to such other remedies as the city may have.
3 4 5 6 7 8	(3 <u>4</u>) Failure to pay any and all fines, <u>or processing fees</u> shall prohibit the building official from issuing any additional permits to said registered or licensed contractor until such time as all fines, <u>or processing fees</u> are paid to the City of Warwick <u>for the subject property</u> ; provided however, if the contractor has three offenses within 12 months of the first offense, then the city may refuse to issue any permit for 6 months after the date of the third offense.
9 10 11	(4 <u>5</u>) All fines, <u>and</u> penalties, <u>or processing fees</u> assessed under this ordinance are in addition to and not in substitution of the contractor's responsibility to obtain the applicable <u>building</u> permits and pay to the city the requisite associated <u>fee amounts</u> .
12 13 14	(c) The building official shall notify the State Contractors Registration and Licensing Board and/or the applicable division at the Department of Labor and Training within five days of any violations issued to a contractor for being in violation of this ordinance.
15 16 17 18 19	Section II. This Ordinance shall take effect upon passage and publication as prescribed by law.
