On 11/12/19 at approximately 1700hrs I officer Elderkin responded out to Alice Ave in order to conduct a traffic survey requested by Councilman McAllister (19-85105). The request came to Councilman McAllister from one of his constituents asking that Alice Avenue be turned into a one way street due to the fact that the roadway is extremely narrow and vehicles are consistently driving up on the reporting parties lawn. The reporting party in this case stated that there are numerous young children who live on this street.

Upon me viewing the roadway structure I did notice that the roadway is very narrow and unsafe for two way traffic to safely negotiate this roadway without having to partially mount lawns and curbing. Alice Ave is a short stretch of roadway that stretches from Grandview Drive to Ferncliff Ave. There are only two houses on Alice Avenue 65 Alice and 35 Alice. The residence at 54 Preston Drive also has its driveway on Alice Avenue. By changing this street to a one way it would have minimal effect on the daily flow of traffic.

There are already a few no parking signs on Alice Ave, however I feel that by hanging 3 or 4 One Way signs on this short stretch of roadway will alleviate the problem. The one way signage should direct traffic in a East to West fashion starting from Grandview Drive towards Ferncliff Ave. Signs should be mounted at the intersections of Grandview Drive at Alice Ave, Alice Ave at Preston Drive, and also some at Alice Ave at Ferncliff Ave. Vehicles traveling South on Preston Drive will be able to make a left hand turn onto Alice Ave out to Ferncliff Ave or continue straight on Preston out to Melbourn Road.

In conclusion it is my recommendation that Alice Ave be converted into a One Way roadway.
