STOPPING, STANDING AND PARKING

Be it ordained by the City of Warwick:

Section I. Chapter 76 Article IV of the Code of Ordinances of the City of Warwick is hereby amended to add the following:

Sec. 76-192. Parking restrictions generally.

(b) *Parking allowed.* Parking is allowed on the following streets and public properties, or parcels of city-owned property as provided in this subsection:

On the north side of Priscilla Avenue only from May 15 to September 15.

On the north side of Ogden Avenue only from May 15 to September 15.

On the east side of Burnett Street from May 15 to September 15.

(c) *No Parking allowed.* It shall be unlawful for any operator of any vehicle to park the same:

~~(199) On both sides of Ogden Street in the area of the boat ramp.~~

~~(218) On the south side of Ogden Avenue from May 1 to September 30.~~

~~(209) On the east side of Burnett Road.~~

Section II. This Ordinance shall take effect upon passage and publication as prescribed by law.

1 TRAFFIC STUDY HIGHLAND BEACH AREA

2016-14

I, Officer Sarkisian of the Warwick Police Traffic Division received a request for a traffic study submitted by Councilman Ladouceur regarding "no parking and parking restrictions" in the Highland Beach area (Priscilla, Burnett, Ogden). Upon receiving the survey, I did respond out to all three locations and did note that there is already posted "No Parking", "No parking this side" and seasonal restriction parking signs in place in the area.

This request was submitted based on several neighbor complaints and/or calls regarding non residents parking in the area and walking to Rocky Point and Highland Beach Area. This parking issue is also a seasonal occupance which is primarily from late spring and runs throughout the summer (weather pending). Upon reviewing the format of the roadway and its current issue with clearance and parking, it is this Officer's recommendation that parking restrictions should be as followed:

Priscilla- One side parking only (north side) from May 15- September 15

Ogden- One side parking only (north side) from May 15- September 15

Burnett- One side parking only (east side) from May 15- september 15

The restricted one side parking will allow for less congestion in the area and ease of travel throughout the neighborhood along with clear driving visibility for all travelers. These current recommended restrictions will be implemented to ALL persons. **Residents of the Highland Beach area will NOT be exempt from these parking restrictions.** It is not a lawful practice to restrict the public from parking on city and/or state owned roadways/property. The city beaches and boat ramp are public ammenties that all should have access to, including the residents of the area and residents guests.

This traffic study will be forwarded back to Councilman Ladouceur and the City Council recommending seasonal restricted parking.
