Be it ordained by the City of Warwick:
Section I. Chapter 8 of the Code of Ordinances of the City of Warwick is hereby amended to add the following:

## Sec. 18-10. - Building permit fees.

(a)....
(b) Schedule of permit fees: Building permit fees are to be based on the valuation of the current construction cost as follows:

See Exhibit A, the existing paragraph (b) is deleted in its entirety and new fees set forth in Exhibit A incorporated herein by reference as if set forth in its entirety shall replace the present fees.

Section II. This Ordinance shall take effect upon passage and publication as prescribed by law.
