19	WHEREAS, the health, safety and welfare of the citizens of the City of Warwick are
20	matters of paramount importance to the City Council; and

22	WHEREAS, Section 2-18 of the Warwick Code of Ordinances requires all collective
23	bargaining agreements between the City of Warwick and any labor organization to be ratified by the
24 25	City Council to become effective; and
25 26	WHEREAS, the Mayor of the City of Warwick and the Warwick Firefighters, Local 2748,
20 27	IAFF, AFL-CIO have reached a tentative collective bargaining agreement to modify the existing
28	contract between Local 2748 and the City and to establish a new three-year contract effective on July
20 29	1, 2022 to June 30, 2025 (the "Local 2748 Tentative Agreement")(Attached); and
30	1, 2022  to valie 50, 2020  (when 200al 27 to Tenant's Highermonic )(Thursdown), and
31	WHEREAS, the membership of Local 2748 ratified the terms and conditions of the Tentative
32	Agreement; and

34	WHEREAS, the City Council has received and reviewed the Local 2748 Tentative
35	Agreement, and

37	WHEREAS, the City Council has been provided a fiscal note concerning the Local 2748
38	Tentative Agreement; and

40	WHEREAS, the City Council is satisfied that the provisions of the Local 2748 Tentative
41	Agreement are reasonable, fiscally sound and advance the public health, safety and welfare of the
