RESOLUTION TO RELOCATE THE STEVE INSANA MEMORIAL SITE

Resolved that,

WHEREAS, the Buckeye Brook Coalition has faithfully maintained a memorial site honoring its founder Steve Insana which includes a stone boulder with a memorial plaque, a bench, and flowers, and

WHEREAS, the memorial site is currently on State of Rhode Island property located on Warwick Avenue, and

WHEREAS, the Rhode Island Department of Transportation will be engaging in a Storm Water improvement project at this site which requires the relocation of Steve Insana's Memorial, and

WHEREAS, the Buckeye Brook Coalition has conducted a diligent search for a new memorial location, and

WHEREAS, a site has been identified on West Shore Road which is owned by the City of Warwick, and

WHEREAS, this site is further Identified as Assessors Plat 354, Lot 033 which is adjacent to a site where the Buckeye Brook Coalition completed a four-year phragmites restoration project, and

WHEREAS, the stone boulder relocation would have a foot print of approximately forty inches by fifty-four inches (40" by 54"), and

WHEREAS, Assessor's plat 354, Lot 033 is of sufficient size to locate the memorial and have appropriate distances from the State Highway for safety, and

NOW THEREFORE, BE IT RESOLVED, that the Warwick City Council hereby authorizes the relocation of Steve Insana's memorial site from its current location on Warwick Avenue to West Shore Road, Assessors Plat 354, Lot 033, more specifically described and

1 measured by reference from the West Shore Road Utility Pole Number 131, thence twenty-five
2 feet (25') southerly along the backside of the sidewalk, thence orthogonal and easterly a
3 minimum distance of seven feet (7') from the back of the sidewalk to a rectangular foot print
4 area approximately forty inches by fifty-three inches (40" by 53").

6 NOW THEREFORE, BE IT FURTHER RESOLVED, that the Warwick City Council
7 hereby authorizes and directs the Warwick Department of Public Works to move the Steve
8 Insana memorial boulder from its current location on Warwick Avenue to Assessors Plat 354,
9 Lot 033 on West Shore Road, Warwick, Rhode Island.

11 The City Clerk from the City of Warwick is hereby directed to forward a copy of this
12 resolution to the City of Warwick Director of Public Works and to the President of the Buckeye
13 Brook Coalition.
