On 06/01/17, Officer Barlow was assigned Traffic Division Survey No. 2017-14, submitted to the Warwick Traffic Unit on behalf of a resident on Taplow St. The resident, identified as Arthur Santagata, resides on Taplow St., and he states that Taplow St. has become a cut through for traffic negotiating from West Shore Rd., cutting through Taplow St. in order to get to Oakland Beach Ave. Santagata states that this happens on weekends and also weekdays, with Santagata estimating the speeds at 45 to 50 MPH by the time vehicles pass his residence. Taplow St. runs parallel to Oakland Beach Ave. in a north and south direction. It is an undivided two-laned road, and at the intersection of Taplow St. and Gordon Ave., there is a large tree which obstructs the view of Gordon Ave. when traveling southbound on Taplow St. There is no signage at this intersection.

A potentially dangerous situation exists. It is recommended that a stop sign be erected in the southwest corner of Taplow St., with a stop bar, as well, in order to control traffic traveling southbound on Taplow St. in order to alleviate the hazard with traffic traveling east and west on Gordon Ave. It should also be noted that that intersection is in close proximity to the Oakland Beach Elementary School.

Officer Barlow will research appropriate signage in order to see if the speed reduction from 25 MPH to 20 MPH in the school zone will be more appropriate. This officer has reached out on multiple occasions to the homeowner and reporting party (Arthur Santagata); however, there have been no return phone calls at this point. The desired signage from the resident was *No Thru Traffic*; however, the stop sign and possible speed signs are deemed more appropriate at this time. Referenced to this report is the City of Warwick City Ordinances and the Manual of Uniform Traffic Control Devices. A speed study has been requested through the Traffic Unit. When the speed sled becomes available, a traffic study will be conducted. Officer Barlow will speak with the Sign Department in order to erect necessary signage in the future.
