The State of Rhode Island has extended the Master Price Agreement (MPA – 105) for General Office Supplies, School Supplies, Standard Paper and Toner through December 31, 2015. The Master Price Agreement covers the purchase and supply of general office supplies and the above mentioned items on an as needed basis for the State.

The City of Warwick receives superior pricing by piggybacking this state bid. The Purchasing Division still continues to check other vendors' pricing on these items to ensure we are receiving the best possible deal for the City of Warwick. Also included through the vendor are the monthly discounts of 2.25% offered to the city on purchases and a cash rebate at the end of the fiscal year based on the city's volume of purchases.

I am therefore requesting that the Purchasing Division be authorized to continue to participate in MPA – 105 with an additional amount of \$15,000 for core items and for non-core items. The city's stock inventory is included in the total request of \$15,000 which allows various departments and divisions the opportunity to purchase key items directly from the Purchasing Division, while department's other specific needs can be met directly through the vendor.



The Police Department is seeking authorization for training expenses in order to host a specialized school at the Warwick Police Department. This school is a Canine Tactical Operations school entitled “ Swat and K-9’s Interacting During Deployment School (SKIDDS) and will be held at the Warwick Police Range Facility and an off-site location to be determined later.

This training is being offered to the Warwick Police department at a discount in return for being the hosting department and therefore, all officers are being trained for the discounted rate of \$250.00 per person. This is a significant discount off the regular tuition cost of \$515.00 per person that is usually charged. Based on this discount, the department will be able to send 16 members of the SWAT team for this training, including our two K-9 Officers.

This school will be conducted by Canine Tactical Operations, P.O. Box 400033 Las Vegas NV 89140. The total cost to the Police Department **\$4,000.00(250.00/pp x 16)**. Obviously, hosting this school saves on the cost of hotels and travel costs and allows for a greater number of participants to gain this training.

If approved, we would host this training from October 26, 2015 through October 28, 2015. Funding for this training would come from the Police Department’s Operating Budget 30-302.
