RESOLUTION ESTABLISHING A COMMITTEE FOR COMMUNITY OUTREACH
WITH THE SCHOOL DEPARTMENT

Resolved that,

WHEREAS, the health, safety and welfare of the citizens of the City of Warwick are matters of paramount importance to the City Council; and

WHEREAS, the City Council has a vested interest in improved and effective communication regarding matters that impact students enrolled in the Warwick School District; and

WHEREAS, a joint committee of elected officials and stakeholders in education will facilitate a sharing of ideas and teamwork to improve communication, relationships and the common good as it pertains to educational goals for all our Warwick students; and

WHEREAS, the City Council desires to establish a committee to improve communication among all persons involved in the local educational system and those responsible for funding that educational system.

NOW THEREFORE, BE IT RESOLVED, the City Council hereby establishes an Educational Community Outreach Committee to improve communication among the students, teachers, the School Committee and school administrators, the city administration and the City Council and serve as a conduit and a liaison for providing information amongst the various parties involved in the Warwick educational system.

BE IT FURTHER RESOLVED THAT said committee shall be composed of the following members:

- Two students
- Two teachers
- One Teacher Union representative
- One School Committee member
- One school administrator
- One city administrator

2 Four City Council persons serving as nonvoting members
3 The Co-Chairpersons of the committee shall be one of the students and the School
4 Committee member.

6 The committee shall exist during the 2015-2016 school year and shall dissolve at the end of
7 the school year unless extended by the City Council.
