**RESOLUTION RELATIVE TO PLACING STOP SIGNS ON
 RIDGE ROAD AND CLIFF ROAD (PYLE LANE) AT THE INTERSECTIONS
 OF CHAPIN AVENUE AND PRISCILLA AVENUE AND STOP SIGNS
 ON PRISCILLA AVENUE AT THE INTERSECTION
 OF PALMER AVENUE**

Resolved that,

WHEREAS, the health, safety and welfare of the citizens of the City of Warwick are matters of paramount importance to the City Council; and

WHEREAS, it has come to the attention of the City Council that a dangerous situation exists at the intersections of:

Ridge Road and Chapin Avenue,
 Ridge Road and Priscilla Avenue,
 Cliff Road (Pyle Lane) and Priscilla Avenue,
 Cliff Road (Pyle Lane) and Chapin Avenue, and
 Priscilla Avenue and Palmer Avenue; and

WHEREAS, a traffic survey was conducted by the Police Department which recommended that stop signs be placed on:

Ridge Road at the intersection of Chapin Avenue,
 Ridge Road at the intersection of Priscilla Avenue,
 Cliff Road (Pyle Lane) at the intersection of Priscilla Avenue,
 Cliff Road (Pyle Lane) at the intersection of Chapin Avenue, and
 Priscilla Avenue at the intersection of Palmer Avenue; and

WHEREAS, the City Council, by virtue of the authority of Chapter 76 Article 1 Section 76-13 of the Code of Ordinances of the City of Warwick, may determine that certain traffic signs are required for the protection of the public safety.

NOW, THEREFORE, BE IT RESOLVED that the Director of Public Works is hereby directed to place stop signs on:

Ridge Road at the intersection of Chapin Avenue,

1 Ridge Road at the intersection of Priscilla Avenue,
2 Cliff Road (Pyle Lane) at the intersection of Priscilla Avenue,
3 Cliff Road (Pyle Lane) at the intersection of Chapin Avenue, and
4 Priscilla Avenue at the intersection of Palmer Avenue; and

7 Public Works and the Chief of the Police Department.
