27	WHEREAS, the Warwick Museum of Art has also applied for a Champlin Grant, for

30	WHEREAS, the City of Warwick wishes to continue leasing the Premises to Warwick		
31	Museum, Inc., for terms which are substantially similar to the previous Lease, which includes but		
32	is not limited to provisions such that Warwick Museum, Inc. is responsible for the maintenance		
33	of the Premises, that it would pay all utility costs, as well as plumbing and boiler repairs should		
34	they occur, the requirement to carry liability insurance and indemnification of the City of		
35	Warwick for any claims that may arise; and

37	WHEREAS, the new Lease Agreement shall be for a term of ten (10) years, starting in		
38	January 2021 and ending in January 2031, and said Agreement shall be approved as to form by		
39	the City Solicitor.

42	hereby authorizes the Mayor to enter into a Lease with Warwick Museum, Inc., for a period not
