17	WHEREAS, the health, sofety and walfers of the citizens of the City of Werwick are
18 19	WHEREAS, the health, safety and welfare of the citizens of the City of Warwick are matters of paramount importance to the City Council; and
20	matters of paramount importance to the City Council, and
21	WHEREAS, Greenwich Avenue (Route 5) is a State; and
22	WILKEIS, Ofcenwich rivenue (Route 3) is a state, and
23	WHEREAS, that section of Greenwich Avenue near Greenwich Village Apartments is very
24	dangerous for pedestrians to cross the four travel lanes of Greenwich Avenue even though there is a
25	crosswalk and a traffic light at the location; and

27	WHEREAS, there was a recent motor vehicle accident at the location in which a pedestrian
28	was struck and killed; and

30	WHEREAS, residents of the area believe there are a number of factors contributing to
31	pedestrians being injured and killed in or near the cross walk, including, motor vehicles speeding,
32	motor vehicle operators ignoring the traffic light at the cross walk, and the traffic light does not
33	provide enough time for elderly residents of the apartments to cross the wide street; and

35	WHEREAS, the Warwick City Council desires that the State conduct a traffic study on that
36	section of Greenwich Avenue near Greenwich Village Apartments to develop traffic control
37	measures to ensure the safety of pedestrians crossing Greenwich Avenue at that location.

39	NOW THEREFORE, BE IT RESOLVED that the Warwick City Council hereby requests the
