20	WHEREAS, the health, safety and welfare of the citizens of the City of Warwick are		
21	matters of paramount importance to the City Council; and		
22	WHEDEAS the Dhode Island Airmort Componetion (DIAC) maintains a preasure that		
23 24	WHEREAS, the Rhode Island Airport Corporation (RIAC) maintains a program that removes obstructions from protected airspace in the interest of public safety; and		
24 25	removes obstructions from protected anspace in the interest of public safety, and		
25 26	WHEREAS, RIAC submitted a firm offer dated April 6, 2022 to purchase permanent		
27	avigation easements on Assessor's Plat 341 Lots 1 and 149 to allow for removal of obstructions		
28	and near obstructions to the navigable air space above the City owned property, currently		
29	comprised of trees; and

31	WHEREAS, RIAC obtained an appraiser to analyze the effects of such avigation easement		
32	to determine the amount of just compensation and have submitted a firm offer to the City of		
33	Warwick totaling \$68,800 for avigation easements: \$52,500 for Plat 341 Lot 1, and \$16,300 for		
34	Plat 341 Lot 149; and

36	WHEREAS, RIAC provided a sample avigation easement agreement to accompany its		
37 38	offer, which is attached hereto as part of Exhibit A; and		
38 39	WHEREAS, Mayor Picozzi accepted RIAC's offer on April 8, 2022 contingent upon		
40	review and approval of the Warwick City Council of the avigation easement agreement, which is		
41	attached hereto as Exhibit B; and

43	WHEREAS, the Warwick City Council desires to grant said easements to RIAC in		
44	exchange for just compensation.

46	NOW, THEREFORE, BE IT RESOLVED, the City Council hereby authorizes the Mayor		
47	to execute avigation easement agreements with the Rhode Island Airport Corporation on		
48	Assessor's Plat 341 Lots 1 and 149 in exchange for just compensation of \$68,800, in the form and		

1	substance as approved by the City Solicitor and consistent with the terms presented in Exhibits A		
2	and B.
