18	matters of paramount importance to the City Council; and

20	WHEREAS, a traffic study was conducted by the Warwick Police Department between			
21	the dates of June 27, 2020 and July 14, 2020 in the area of Bucklin Avenue and Sand Pond Road;

23	WHEDEAS the traffic study contained a thereway observation of the volume of traffic			
24 25	WHEREAS, the traffic study contained a thorough observation of the volume of traffic			
25 26	venturing upon these roads and their proximity to Post Road; and			
26 27	WHEREAS, there have been multiple traffic studies conducted of these reads by the

35	WHEREAS, it was the ultimate recommendation of the traffic study that a "Local Traffic			
36	Only" sign be erected at the southeastern portions of both Sand Pond Road and Bucklin Avenue;

39	WHEREAS, the traffic study further concluded that a "Local Traffic Only" sign be			
40	erected at the second telephone pole on Sand Pond Road, west of Post Road, and that another			
41	"Local Traffic Only" sign be erected on Bucklin Avenue, one hundred twenty-two (122) feet			
42	from Post Road, at the northwestern portion of the property located at 15 Bucklin Avenue.

44	NOW THEREFORE, BE IT RESOLVED, that the City Council hereby requests that the			
45	aforementioned signs be placed in the areas recommended by the traffic study.
