## 2021-30

On 10/26/2021, I officer Elderkin received a request for a traffic survey from Councilman Ladouceur for the placement of stop signs at the intersections of Meadow View Ave and Clifton Ave, and also for the intersection of Paine Street and Chatfield Street. (It should be noted that Meadow View Ave turns into Chatfield street in the area of Paine street).

On 10/26/2021, I responded out to this location and met with Councilman Ladouceur and discussed the traffic flow and upcoming construction plans for these intersections. It was brought to my attention that the City has recently been gifted this section of roadway that had previously been owned privately. The intersection where Meadow View Ave, Clifton Ave and Leroy Ave come together, will be under construction in the near future as the dividing island at this intersection gets reduced in size to allow traffic to flow in both directions on Meadow View Ave.

It is requested that a Stop sign be placed on Meadow View Ave at the corner of Meadow View Ave and Clifton Ave to stop the traffic coming off of Meadow View Ave. There is also a request for a stop sign at the intersection of Paine Street and Chatfield St. This stop sign would be to stop the traffic coming off of Paine Street onto Chatfield St (Meadow View Ave). Due to the curvature of this corner the Stop sign may need to be mounted further up on Paine Street, therefore a Stop bar must be painted on the roadway indicating the stop position.

Upon surveying the roadway and meeting with the councilman it is my recommendation that both of these stop signs be approved.
