Note 1: If jurisdiction will allow the testing company to exclude duplicate questions only from tests for the same rank for a period of four years and allow the testing company to use the same question on test for other ranks with the answers scrambled, the \$695 charge will be waived. Since the technical questions are most likely to come from the textbooks, and different textbooks are used for different ranks, duplicate questions will most likely only come from jurisdiction sources such as Warwick SOP's and policies
