INTRODUCTION

Earl Bond, the Executive Director of the Warwick Sewer Authority (WSA) opened the Prebid meeting with introductions of the Construction Management Team.

Todd Ravenelle of Gordon R. Archibald, Inc. (GRA) presented the following on the proposed project.

DIVISION 01 – GENERAL REQUIREMENTS

- 1. Section 01010 Summary of Work / History
 - The project is located within an area containing a significant concentration of Native American cultural materials and features.
 - These cultural materials and features have required the design to utilize trenchless technologies and a pressure sewer system.
 - Mainline Sewer Main will be installed utilizing trenchless and open cut methods, 55% / 45%, northerly half of the project will utilize trenchless technologies and the southerly half will be open-cut excavation, tradition method. The limits of each work type are indicated on the plans.
 - Service connections will be installed by trenchless technologies for the entire project.
 - Excavation limits must be maintained within the cleared pre-excavated 8'x8' areas within trenchless technologies main line areas.
 - Tidewater Drive excavation limits must be maintained within the pre-excavated trench limits and outside of areas of archaeological significance. Survey locations of the trench limits will be provided to the successful bidder.
 - Should excavations be required outside of pre-cleared areas, the proposed area will be reviewed, investigated and cleared by the WSA's Archeologist.
 - In concept, the design of the service connections is to install the service to approximately 5 feet of the foundation. We have shown proposed service location on the plans. These locations were determined by coordination with approximately 50% of the homeowners (those who responded) and the other location were made by field review. It is understood by the WSA that locations made not be achieved or may need to be adjusted based on field conditions. The WSA is in process of preparing a waiver/service card for homeowners. These cards will confirm the preferred location and provide terms and conditions of the services with the Homeowner. The card will provide a condition survey checklist to assist in avoiding utility conflicts and/or subsurface obstructions.
- 2. Section 01014 Work Sequence A work sequence is provided in the Contract Documents. Work zones are indicated on the plans. Work zones will be activated as they are completed.
- 3. Section 01025 Measurement and Payment The work included within each bid quantity is described in this section.
- 4. Section 01340 Shop Drawings Reference was made to submittal requirements for Directional Drilling.
- 5. Section 01570 Traffic Control The WSA will directly pay for police protection.

6. Section 01800 - Archaeological Provisions – Reference is made to this section. Procedure are provided should archeological features be encountered.

DIVISION 02 -FEDERAL AND STATE REQUIREMENTS

1. Section 02100 - R.I. Department of Environmental Management – Office of Water Resources - Clean Waters State Revolving Fund Program – Contract Specifications Package – Bidders were advised to review this section.

DIVISION 03 – EARTHWORK

- 1. Section 03750 Dewatering Project Wide Dewatering will not be paid separately but is included in the price of the various bid items.
- 2. Section 03800 Erosion and Sedimentation Controls Bidders are advised that erosion and sedimentation controls must be maintained in accordance with the Soil Erosion and Sediment Control Plan provided in the Appendix of the Contract Documents.

DIVISION 04 – PAVEMENT

1. Section 04305 - Asphalt Paving – The entire project will receive a bituminous pavement overlay upon completion of work.

DIVISION 05 – UTILITIES

- 1. Section 05400 Electrical Utility Services Provision have been provided for conflicts with overhead electrical services.
- 2. Section 05610 Sanitary Sewer Trenchless Technologies Bidders were advised to review this section.
- 3. Section 05812 Horizontal Directional Drilling Bidders were advised to review this section.

The following question were made by Bidder's at the meeting.

- 1. Comment: Is filter fabric needed on open-cut trench excavations for pipe?

 Response: GRA indicated filter fabric is not necessary. This will be corrected by Addendum
- 2. Comment: Are all manholes 72-inch diameter within open-cut trench excavations. *Response: GRA will review and clarify by addendum.*

3. Comment: How will Contractor's be compensated for a work stoppage due to an archeological find during excavations.

Response: GRA will review and clarify by addendum.

4. Comment: Do Bid Items 57 and 58 - Isolate and ReactivateWater Main Less Than 40 feet and - 40 - 80 feet include the cost of the pipe? Or is the pipe paid under Items 60 and 61, 6-inch and 8-inch water main.

Response. Items 57 and 58 include the labor, materials and equipment to install the water pipe.

5. Comment: Can excavations be plated overnight?

Response: Yes, GRA will provide additional information by addendum.

6. Comment: Can the withdrawal limit of 20 feet be reduce in confined work areas. (This question relates to Section 05812 – Horizontal Directional Drilling paragraph 3.9, item I)

Response: Yes, the withdrawal limit can be reduced. GRA will revise by addendum.

7. Comment: Where can drill spoils and excavated fill be disposed? *Response: GRA will provide additional information by addendum.*

8. Comment: How is rock excavation paid for in directional drilling? What provisions are provided for retrieval if the drilling operation is obstructed?

Response: GRA provided an incorrect response to this comment during the meeting. There is no item for retrieval. Also, payment for drilling rock is an added cost a not a separate cost. GRA will clarify and revise by addendum.

9. Comment: How will payment for refill of rock excavations be paid.

Response: Fill material will be paid by Item 10 - Additional Gravel Borrow.
