Attorney Mancini: Okay, that was my next question, where to send it all.

Chairwoman Baxter made a motion to approve pending Building, Fire, City and State taxes, and Rhode Island Department of Health approval. Vice Chairman Paolucci seconded the motion. Chairwoman Baxter, Vice Chairman Paolucci, and Clerk McGovern voted in favor of the motion. Motion approved.

11. Liquor License Violation – Grid Iron Ale House & Grille – Sunday, April 16, 2017

"On 04-16-17 at approximately 0405 hours I, Officer Javier Cabreja, was dispatched to the lobby at Warwick police headquarters to take a report from an assault that had occurred in the past.

Upon arrival Lieutenant Read was speaking with two males who wanted to report an assault that had taken place earlier this morning at the Grid Iron Ale House located at 1599 Post Road. After speaking with the two males, the lieutenant exited to grab a camera to take photographs of the injuries of one of the subjects.

I made contact with both parties. I first spoke with Richard Burr DOB 09-06-86 who had an injury to his right eye. It looked like he had a gash slightly to the right of his eye near his temple. He still had blood on his face and some on this throat area. Rescue was dispatched to HQ's even though Burr declined rescue. Officers wanted to make sure that Burr had rescue evaluate his injuries due to the amount of blood on Burr's face.

Burr was accompanied by his brother Michael Macchioni DOB 04-19-95. He had been with Burr at the Grid Iron where the assault took place. Rescue arrived and checked Burr. He refused medical. He stated that he would be okay and did not want medical attention. He said that he would self-medicate. After rescue left I asked both Burr and Macchioni to provide a written statement.

Burr provided a written statement and verbally stated that he was accused of something that he did not do at the bar. He indicated that the officers could look at video surveillance from the bar. Burr said that he was hit with a bar stool due to the fact that a girl grabbed his arm in a friendly way. He then made a gesture for the girl to leave him alone. That girl was identified as a possible Nicole Mallett. Apparently Burr didn't want anything to do with Nicole. He flailed his arm toward her in an attempt to get away from her.

At that moment the female advised her male friend that Burr had assaulted her. Later Burr was assaulted. He said that he was almost murdered. He was struck with a bar stool one inch away from his temple according to Burr. He fell to the ground and stood right back up. Everyone ran out of the bar except a few. Burr stated verbally that he would describe the scene as very hectic and chaotic inside the bar. He went to his car because people were trying to kill him and chasing him. When he was able to get home, he contacted the police around 0117 hours. Refer to call #17-1984. He wanted the officers to check the area of the Grid Iron to see if there were any remaining suspects at the bar so they could investigate the assault. Burr stated that if the officers locate a suspect, he would like to press charges for his injuries.

Macchioni told me that around closing time he noticed a glass break and almost immediately a bar stool was thrown at his brother Richard Burr. The brothers saw the person who threw the chair but they did not know who he was. They recognized him from earlier from being at the bar. The person ran away from the bar toward the parking lot after he threw the bar stool. Macchioni said he attempted to run after the person, but he was held by a tall gentleman who was part of the chaotic scene, part of the crowd attempting to incite a fight. He confronted the person who was responsible but did not want to start a fight. The suspect ran away.

Macchioni knew that that person who threw the stool was a friend of Nicole Mallett. She was at the bar. He indicated that apparently Nicole put her hands on Richard, grabbing him. He pulled back from her. At that moment Nicole advised a tall gentleman that she had been assaulted by Richard. He described it as a chain of events that led to anger and the white knighting effect of the individual who threw the stool due to the false accusations made by Ms. Mallett. These false accusations led to the assault. He

described white knighting as someone who felt that they needed to avenge an individual who was a victim of a crime.

Both individuals stated that they did not call the police immediately as it happened due to Burr attempting to get away from the chaotic scene. Macchioni was attempting to shield his brother from any additional assaults. When they got home, they contacted the police. Officer Steven Moretti, and I responded to the Grid Iron.

According to employees at the Grid Iron, they stated that there were about 30 people involved. They verified that a person and a stool was thrown, but everybody ran away from the bar. There was no suspect data. There was no information. I explained to the workers that they need to notify the police about such incidents, especially when an assault takes place at their place of business. The employees were advised that this in violation of their license.

At that time Officer Moretti cleared the call because there was not enough suspect data available. At that time, Richard Burr wasn't being cooperative.

At this time it appears that Burr was a victim of simple assault. There is no suspect data available, but this case will be forwarded to district one detectives for further investigation. In addition it will be forwarded to licensing due to the Grid Iron employees admitting that they did not call the police. Dispatch advised that there were no calls from Grid Iron this morning regarding any incident.

Due to the aforementioned facts the management of Grid Iron Ale House & Grille is in violation of the following rules and regulations issued by the Board of Public Safety for the orderly establishment of liquor establishments."

7. SUPERVISION OF LICENSED PREMISES AND ASSOCIATED AREAS:

D. All fights, disturbances or other violence shall be reported immediately to the Warwick Police Department by the licensee.

Second charge added - May 4, 2017

The female minor found in your establishment, Nicole Mallett (19 years of age), named throughout the report of Sunday, April 16, 2017 did not sign the minor book. Therefore, you are in violation of the following rules and regulations issued by the Board of Public Safety for the orderly operation of liquor establishments.

ACTION: Chairwoman Baxter made a motion to approve. Vice Chairman Paolucci seconded the motion. Chairwoman Baxter, Vice Chairman Paolucci, and Clerk McGovern voted in favor of the motion. Motion approved.

45. Letter of request from Laurie Jansen of 84 Dayton Avenue to be granted an exception to City Ordinance O-11-5, Sec. 4-11, allowing her to house more than three dogs at her residence.

Colonel McCartney: I believe in her packet you also have a letter explaining her need for that so that the Board understands exactly what she's requesting.

Chairwoman Baxter: All right, so you have three mini Dachshunds at your house right now?

Ms. Jansen: Yes.

Chairwoman Baxter: You're looking to adopt two more mini Dachshunds.

Ms. Jansen: They're actually mini dachshund Chihuahua mixes if that matters.

Chairwoman Baxter: Oh my goodness, so they're even smaller.

Ms. Jansen: They're very small. One is eight pounds and one's nine pounds.

Chairwoman Baxter: Okay, and the two mixed; excuse me, fixed mini Dachshunds males that will be trained to do therapy. Okay wait, who is Bailey in the wheelchair?

Ms. Jansen: Bailey is a dog that currently lives at my house. He's a mini Dachshund.

Chairwoman Baxter: And he's in a wheelchair.

Ms. Jansen: He's in a wheelchair. He can't, he's not a working dog; he's not able to work. But, Buster does canine search and rescue with myself, and Rudy works at Providence Airport.

Chairwoman Baxter: Wow, these dogs, you've got them busy.

Ms. Jansen: The other two potential pups would be the funeral home therapy dogs. They're being housed in a foster in Connecticut. I had two others that I had scoped out before when I had initially sent this. I went and met them in Massachusetts. They won't successful with my dogs; they're too...so I have these other two potential ones in Connecticut. They're from Texas. They're both rescues.

Chairwoman Baxter: And how old are all of these guys?

Ms. Jansen: The two potential are three and four, Rudy is five, and the other two are eight, they're litter mates. They're all rescues and they're all fixed.

Chairwoman Baxter: Okay, so Buster and Bailey are eight. Okay. So you have a fenced in yard, fenced in deck; and during the day - -

Ms. Jansen: [interposing] I'm a school teacher. They're inside; they don't go out without me.

Chairwoman Baxter: So they're inside during the day when you're out?

Ms. Jansen: Oh yes, yes. They're never outside when I'm not home.

Chairwoman Baxter: Okay, and Colonel you said you have no complaints about the three guys that are there now?

Colonel McCartney: No complaints at all.

Chairwoman Baxter: Okay, do you want to do a review.

Vice Chairman Paolucci and Clerk McGovern are heard agreeing.

Chairwoman Baxter: Okay, so what we've done in the past with folks asking for extra dogs is we'll do a review in six months to make sure how things are going. If anything happens before, we'll hear about it.

ACTION: Chairwoman Baxter made a motion to approve two additional dogs with a six month review at the first meeting in November, 2017. Vice Chairman Paolucci seconded the motion. Chairwoman Baxter, Vice Chairman Paolucci, and Clerk McGovern voted in favor of the motion. Motion approved.
