Overall Progress Narrative:

The Warwick Pond Buckye Brook Phragmitae Removal Activity is 95% complete. The Activity began, in July of 2022, with mobilization and contracotr set-up. Due to weather, the herbicide application was delayed until the end of August beginning of September 2022. Once the herbicide was absorbed by the Phragmitae for more than 20 days, the Contractor began excavating the material and storing it in the dewatering areas.

Once the material dewatered long enough the material was tested and the material was brought to RI Resource Recovery Corporation for disposal. The Contractor disposed of over 3,100 tons of excavated material through December 19, 2022. After disposal of material the demobilization and site restoration began in the fall of 2022. The contracotr completed demobilization but could not finish the site restoration. There was no work over the winter months as the ground cover was frozen and at times too muddy to work in.

The Contractor re-started the site restoration end of March 2023 and is expected depending on site conditions through May 2023, with a completion of June 2023.

It is anticipated that there will be funds remaining tint he grant due in part to a lesser amount of material beign excavated than anticipated.
