AVAILABLE PERSONAL TAX EXEMPTIONS

ALL exemptions require residency. Exemptions on Real Estate can only be applied to your primary residence. A current valid state issued Driver's License (or non-driver's photo ID issued by the DMV) is required for ALL personal exemptions listed below. This list contains summary information only, additional documentation may be required.

All exemption amounts are shown as tax dollars deducted from the total bill.

SENIOR: \$415.20 Real Estate

Must be 65 years of age by December 31st of the prior year in order to apply

VETERAN: \$138.40 Real Estate

Must meet eligibility requirements in accordance with RIGL § 44-3-4

VETERAN 100% DISABLED SERVICE CONNECTED: \$346.00 Real Estate

Must submit award letter from VA stating 100% service connected disability

PARAPLEGIC GI: \$692.00 Real Estate

Must submit documentation of paraplegic status

POW: \$519.00 Real Estate

Must submit documentation of POW status

- All Veterans exemptions can be applied to the same property
- All veteran exemptions are transferable to unmarried widow or widower

GOLD STAR PARENT: \$207.60 Real Estate

Must submit letter from US President

BLIND: \$622.80 Real Estate

Must submit ophthalmological report form from RI Services for the Blind & Visually Impaired stating that the owner is legally blind in accordance with RIGL § 44-3-12

<u>CIRCUIT BREAKER</u>: \$600.00 to \$1000.00 based on income level. Application forms must be submitted every year and may only be applied to your primary residence.

Must be 65 years of age OR 100% disabled per SSA or VA by December 31st of the prior year

Must have been a Warwick resident for the past 5 tax years

Must submit disability award letter from SSA or VA

Must submit income forms stating ALL funds received by ALL occupants

TAX FREEZE: Real Estate taxes may be frozen at current assessment and tax rate. This exemption is only available on a single family home or condominium.

Must qualify as Head of Household (as defined by the IRS) and be 100% disabled per SSA or VA **and** <u>unable to work</u> **OR** be 70+ years of age and have annual household income under \$7,500 (single) or \$15,000 (married couple) Must submit disability award letter from SSA or VA showing 100% permanently disabled status Must submit tax return, or other documentation proving Head of Household filing status (if not required to file).
